2024 AERO PRECISION/STAG ARMS RANGE PROGRAM DETAILS

Aero and Stag are passionate about supporting firearms ranges across the country and assisting in efforts to build new business within the shooting market. We are proud to announce our new range program that helps introduce left- and right-handed shooters to our feature-packed firearms offering. Ranges enrolled in the program will be added to our dealer locator with a special Range Program Member designation.

Conditions for approval:

- Approval by Aero Precison or Stag Arms LLC sales managers.
- Sign and return the Range Program Agreement.
- Current Federal Firearms License (FFL)*
- Aero Precison and Stag Arms products will be prominently displayed for range rentals for a 1-year period.
- Scheduled promotional events/demo days with Aero Precison or Stag Arms sales staff. (1 per year)
- There are <u>NO</u> exceptions in conditions for approval.

Range agrees that the purpose of the program is to:

- Increase new shooter participation at the facility.
- Support the shooting sports
- Support and practice proper gun safety and handling.
- Promote sales of Aero Precison and/or Stag Arms products.

Pricing and terms for 2024 Range Program:

- Range gun pricing is based on the 2024 Aero Precison and Stag Arms Price List and is 35% off Wholesale
- Range Program Orders can only be placed ONCE a calendar year.
- A total of 7 rifle SKUs may be ordered for the range, one of which have to be a SOLUS or PURSUIT bolt rifle. One additional matching SKU may be ordered for each Range Program SKU as a saleable unit.
- Additionally, 4 SKUs from Aero Precision Lahar Suppressor line are available with an additional sellable unit.
- The 7 range guns and 4 suppressors must be used as rentals for a full year before resale. Violators will no longer participate in the Range Program.
- Range Program **REQUIREMENT** on each order of one left-handed model.
- All invoices regardless of ship date must be paid at the time the order is placed.
- All back-ordered products will be canceled two week priors to end of current calender year.
- Range Program limits are based on the number of individual range locations within a multi-location dealer. (For example, a multi-location dealer with 5 total locations, but only 3 having on-site ranges would qualify to participate separately for each of the 3 range locations only)

Product restrictions:

- No more than twenty two (22) SKUs per plan
- Complete uppers and lowers are excluded from the program
- Parts and accessories are excluded from the program

Mandatory models required to participate in the program:

- 1 left-handed model (any caliber) Please note: Model selection subject to availability
- 1 Bolt Rifle. SOLUS or PURSUIT.

Aero Precision and/or Stag Arms reserve the right to cancel the agreement when any of the following conditions are not met:

- Lack of support to Aero Precison or Stag Arms brand.
- Poor maintenance of firearms.
- Payment issues.
- Firearms used in an unsafe manner.
- · Misuse of program discounts may result in immediate termination.

2024 AERO PRECISION/STAG RANGE PROGRAM AGREEMENT

This RANGE PROGRAM AGREEMENT ("Ag	greement") is made and entered into as of	, 202, by and

For and in consideration of the mutual promise and covenants contained herein, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree as follows:

Aero Precison/Stag Arms will accept the sales order attached and made a part of this Agreement, for the model or models indicated on the order form at the price indicated, contingent on the following:

- 1. Range agrees that the Aero Precison and Stag Arms products purchased, pursuant to this Agreement, will be made available for use or purchase at the Range facility and that said facility will include on the same premises the following:
 - Multiple shooting lanes
 - Range must meet all Federal/State guidelines including OSHA requirements
 - Open to the public by membership or walk-in
 - Current FFL
 - Premises must be maintained in a clean, orderly, and well-lit condition
 - Range must be regularly open during set business hours
 - Employees of the range must be present during regular business hours
- 2. All Aero Precison and Stag Arms products purchased under this Agreement will be properly maintained as range firearms for use by the general public or by members of the Range facility at the address of the Range for a period of one year. During the life of this Agreement, the Aero Precison and Stag Arms products sold under this program will be repaired or replaced by Aero Precison or Stag Arms in accordance with their respective warranty. The warranty process must be followed for any product that needs to be serviced or replaced.
- 3. The Range will proudly represent itself as an official Aero Precison and Stag Arms range during the term of this agreement. The range agrees to prominently display signage provided by Aero Precision and Stag Arms as intended for its official range and be represented on Aero Precision and Stag Arms dealer/range locator.
- 4. The Range holds Aero Precison, Stag Arms, and its employees and affiliates harmless and agrees to indemnify Aero Precison, Stag Arms, and its employees and affiliates from any legal action regarding the misuse of any product purchased under this Agreement.
